Overview

When visiting or using the features and services offered at www.liveworkplaycolumbus.com (the "Website") provided by the Columbus Chamber of Commerce ("we", "us", or "our"), we may request and/or otherwise collect certain information from you. This Privacy Policy describes what information about your business and other information that may be collected by us and how we use and disclose such information. This Privacy Policy applies only to information collected on-line through this Website.

Information We Collect

1. Navigational Information

We may gather navigational information during each user's visit to the Website. In the process of gathering navigational information, non-personally identifiable information (e.g., domain type, browser version, service provider and IP address) may be collected. Such information may be gathered by us to learn more about the technical efficiencies of the Website (such as the time it takes a visitor to connect to the Website or download pages) and the use of the Website by visitors, including the areas of the Website that are most visited or the time of a last visit to a page on the Website. We use this information to better understand and improve a visitor's experience at the Website.

2. Business Information and Personal Information

We collect the following categories about you and/or your business when you request to be listed on the Website: your name, organization name, email, and URL. We may also collect any personal information that you include when you contact us.

How We Use and Disclose Your Information

The information collected on our Website will not be sold or rented to third parties. Any information you provide on this Website is used to enable us to provide services and features offered on the Website, to respond to your inquiries or requests, to promote this Website and/or the services and features provided by the Website and to support the mission of the Columbus Chamber of Commerce.

The Columbus Chamber of Commerce does not sell or rent any of the personal information collected from you to third parties. However, we may use third parties to provide specific services, such as maintaining the Website. These third parties may have access to and use of the information collected from you in order to perform services for us.

If we were ever merged with, acquired by or acquire another business entity, some or all of the personal information collected about you would be shared with this entity, as well as retained by us. You should also be aware that we may disclose specific information about you if necessary to do so by law or based on our good faith belief that it is necessary to conform or comply with the law, protect the users of our Website or the public, or resolve any type of dispute.

Cookies

On our Website, we use a browser feature known as a cookie. A cookie is a small data file that is stored by your web browser on your computer. Cookies are used to pass information as you go through the pages within our Website. We use cookies to help deliver a better experience on our Website and to remember you when you return to our Website.

For your convenience, our Website may contain links to other sites or other advertising of third party sites, products or services. We are not responsible for and do not endorse the privacy practices or the content of any such sites, products or services.

Privacy of Children

The Columbus Chamber of Commerce does not knowingly collect or maintain information provided by children under the age of 13.

Security

You will have the ability to select and use a password to help prevent the unauthorized access your account information by others. The security of your personal information depends on your protection of your account password. Please do not disclose your account password to unauthorized people. Additionally, we use SSL encryption technology to provide security while information is being transmitted over the Internet. While we implement the above security measures on this Website, you should be aware that 100% security is not always possible.
